## 1. Introduction

- 1.1. This report details the consultation activity undertaken by the applicant (Swansea Council SC) with members of the public and local stakeholders in relation to proposals for the regeneration of Castle Square in Swansea.
- 1.2. A new regeneration scheme is proposed for Castle Square, to raise its quality and to make it more active, distinctive and vibrant.
- 1.3. The aim of SC is to bring about a revitalised public space with new uses to bring Castle Square in line with the wider programme of regeneration already taking place in Swansea, reinforcing the aim of making it an attractive city to live, work and visit. A modern, functional and well-maintained public space is needed, where people will want to spend quality time and relax, which can still accommodate a range of events and cultural experiences.
- 1.4. An initial concept scheme was been prepared for the Square, which took on board all these requirements. The plans for the square include:
  - A new welcoming space with more useable green space, and landscaping increased from 25% of the current area to more than 40% to bring in more character, colour and biodiversity.
  - A greater number of trees with most existing trees remaining.
  - New food and drink units -cafes or restaurants set within an attractive new family friendly space, with canopies providing shade and shelter for people to sit outside and relax.
  - The existing water fountain to be removed, and replaced with a fun water jets feature with minifountains rising from the paved area.
  - An upgraded paved area which is accessible to all and pedestrian friendly.
  - Improvements to make Caer Street and Castle Bailey Street to make them more pedestrian-friendly
    and improve connectivity with the city's castle and an improved Wind Street.
- 1.5. The amount of space for people to gather, sit out and relax would remain the same. It would remain a pivotal focal point for events and gatherings such as those held there before the pandemic.
- 1.6. Engagement and consultation with local stakeholders are a vital part of the planning process and, prior to submitting a planning application, SC has sought to engage meaningfully with a range of relevant parties in order to gain feedback and evolve the proposals.
- 1.7. Where appropriate, suggestions for improvements/changes will be incorporated into the final design.

- 1.8. As a result of COVID19, an online consultation took place between 4th March 2021 and 19<sup>th</sup> March 2021, along with five stakeholder meetings, targeted at local businesses, stakeholders and likely consultees of the planning application.
- 1.9. The consultation was undertaken during the COVID19 restrictions and therefore was undertaken in accordance with all relevant guidance.
- 1.10. This statement documents the meetings and feedback from the questionnaire by setting out the key conclusions and discussions.

#### Children and Young People

- 1.11. In December 2021, once Covid restrictions eased direct face to face consultation was undertaken using the council's consultation cabin set up in the Christmas market. Regeneration officers worked jointly with youth work co-ordinators to engage in conversations on the future of the Square. This raised a number of interesting points on safety and security in the space, use for learning ,culture, play and activity.
- 1.12. The scheme has been screened and assessed in terms of relevance to the Equality Act 2010, Socioeconomic Duty and Well-being of Future Generations (Wales) Act 2015 .Consequently a full Integrated Impact Assessment report has been undertaken .



## 2. Stakeholder Meetings

- 2.1. This section documents the stakeholder and consultee meetings. The purpose of the online consultation was to give local stakeholders and likely consultees to the planning application an opportunity to view and comment on the proposals.
- 2.2. The consultation process plays an important role in ensuring that the local stakeholders remain wellinformed of the proposals, to gain vital local knowledge and to help stakeholders to play an active role in the planning process.

#### Meetings

- 2.3. In March 2021, five meetings took place to explain the proposals with key stakeholders to gain their feedback. All meetings took the form of a video conference call, in accordance with COVID19 restrictions.
- 2.4. In attendance at the meetings were various stakeholders from within Swansea Council, as well as external key stakeholders from the business community, including the leader of the local business group, the Woodland Trust and Natural Resources Wales, Wales Extremism and Counter Terrorism Unit (Wectu), Access Groups, Business Improvement District (BID) and GI Professionals.
- 2.5. Each meeting involved an overview of the proposed scheme followed by an informal discussion to allow the development team to answer any queries, to identify where support was being offered and to take on board any concerns and identify areas for further discussion/improvements.
- 2.6. The first engagement meeting took place on 3rd March 2021 with Russell Greenslade, the Chief Executive of the Swansea Business Improvement District (BID). Mr Greenslade represented the BID members, a number of whom will be interested in the changes proposed given the proximity of their businesses to Castle Square. The feedback on the proposals was broadly positive and support was offered, via the BID network, to advertise and encourage engagement in the survey (detailed in section 3). Mr Greenslade was keen to explore how interactive technology could be incorporated into the development to help local businesses understand footfall, demographics and visitor profiles to the area.
- 2.7. It was suggested that there is an appetite for the commercial units being proposed as a number of businesses have expressed an interest in the floorspace.
- 2.8. A meeting took place on 4 March 2021 with the Woodland Trust. The following points/issues were discussed:
  - Concern was expressed about the loss of trees unnecessarily It was pointed out that the value of the current trees at Castle Square when assessed by SC's arboricultural officer was mixed although the aim is to retain as many trees as possible.



- The importance of public consultation was stressed as well as consultation with the Woodland Trust. An offer was made to establish a working group to comment on tree species and to help the public engage in the process. Further engagement on species types was welcomed, but it was also pointed out that input would be required on species that would be tolerant to the Sustainable Urban Drainage solution that would be required for the site.
- It was recognised that the landscape proposals are challenging given the gradient of Castle Square but they were considered a significant improvement.
- Opportunities to add further greenery were suggested. It was pointed out that the site is a sensitive archaeological area and Cadw has raised concern about connections with the Castle.
- 2.9. Further comments from Woodland Trust included:
  - The landscape proposal was considered positive.
  - It was confirmed that their remit is trees and protection. They understand that some removal is required for the bigger picture, taking a pragmatic approach.
  - There is a need to ensure the planting beds and new trees are maintained for biodiversity increase and a need to secure long term upkeep and maintenance.
  - On clarification on why the two trees were specifically identified for removal (the regeneration is dependent on making way for commercial units) it was viewed as acceptable. It was considered positive that the mature trees were remaining.
  - It was suggested that the tree forum is good for tree planting knowledge and they worked with many local authorities previously. The Woodland Trust see it as a real opportunity to improve relationships with SC after previous issues on Wine Street.
  - Further engagement was encouraged.
- 2.10. A meeting took place on 9<sup>th</sup> March 2021 with officers from Swansea Council responsible for Sustainability, Equality, SABS (drainage), Landscape and Nature Conservation. The Sustainable Places Officer from Natural Resource Wales was also in attendance. The following background was set out at the start of the meeting:
  - Approximately 12 months ago, there was a different concept presented one with a harder landscape design. Comments have been taken on board around need for more greenery, better Green Infrastructure (GI) and SUDs strategy.
  - A new design was commissioned which has increased GI and SUDs.
  - The latest proposals increase green space from 25% to 41% of the square.
  - The concept has been approved by SC Cabinet to take forward to detailed design.
- 2.11. A discussion took place around the following:
  - The need to consider how any SUDS structures would avoid DCWW easements and how they might link in with wider regeneration initiatives.
  - The importance of incorporating SABS into the landscape design at an early stage was stressed.



- Positive feedback was given on the increase in green space being proposed. NRW identified that there
  are five principles for Green Infrastructure strategy that the landscape architect should take on board.
- The importance of the choice of plant species to link to the Tawe and Waterfront wildlife corridors.
- The need to look at the practicalities of raised planters and whether more rain gardens might be incorporated into the scheme.
- The introduction of play space into the proposals was welcomed.
- Careful choice of species in relation to the green roofs was discussed, along with their function.
- Further engagement is to take place in respect of species mix and technical detailing on SABS design.
- 2.12. A meeting took place on 15th March with Swansea Disability Forum, SightLife, Guide Dogs Cymru and local ward members as well as project team members. Issues including tactile paving, hand rails, colours of paving were discussed. The design team took these comments on board and will try and incorporate them where possible.
- 2.13. A meeting was held with the South Wales Police Crime Prevention Design Advisor and the Wales Extremism and Counter Terrorism Unit (WECTU) on 19th March 2021. The regeneration was broadly welcomed given the current problems with Castle Square. Existing issues of anti-social behaviour and rough sleepers were raised. Security of the performance area was raised as a potential issue.
- 2.14. The difficulties of designing an open and inclusive public space whilst minimising potential for anti-social behaviour were recognised. On the whole it was felt that the redesign will help to improve the area.
- 2.15. Welsh Government legislating for new laws on crowded places was raised. This was seen as a very exciting proposal but a question was raised over whether there will be protection from vehicle impingement and terrorism threats. A full security review is required to understand risks and how they will be overcome.
- 2.16. The use of curves, slopes and bushes increase the threats ad there needs to be an understanding of how the project team aims to design out terrorism/crime. Help from experts to reduce the risk from crime would be welcomed.
- 2.17. Clarification was sought over whether the development is part of the CCTV area. Consideration needs to be given to potential for the area to be used for protests and gatherings and as such it is important to assess safety.

## 3. Questionnaire Feedback

3.1. Feedback from the public was gained via an online resource and questionnaire. The consultation website was available on the Swansea Council webpage at the following address:

- 3.2. Images of the consultation webpage can be found at Appendix 1. The public were encouraged to view the proposals and provide feedback via a questionnaire. Publicity was provided by means of:
  - Council website
  - Social media
  - Site notices and flyers sent to individual businesses by email addresses
  - Web links sent to multiple stakeholder and interest groups
  - Video clip played on the Caste Square TV screen to make people aware of the consultation.
- 3.3. Comments were submitted online via a feedback form or people had an option to email comments to a dedicated email address (castlesq@swansea.gov.uk). The consultation documents and feedback form were available in other formats if requested.
- 3.4. Questions on the feedback form were as follows:
  - Q1: When you are in the City centre, how often do you visit or spend time in/around Castle Square?
  - Q2: What was the main purpose of your visit last visit to Castle Square?
  - Q3: Do you agree or disagree with the proposal to add more greenspace to Castle Square?
  - Q4: Please explain your answer here.
  - Q5: What sort of new greenspace would you like to see in the Square?
  - Q6: New small cafes or restaurant units set within an attractive new family friendly space with canopies will provide shade and shelter for people to sit outside and relax. Do you agree or disagree with the proposals to add café /restaurant uses in Castle Square?
  - Q7: Please explain your answer here.
  - Q8: A new water feature is proposed for Castle Square, which can be switched on and off to allow use of the space for events. Do you agree or disagree with the proposal to add a new water feature in the Square?
  - Q9: Please explain your answer here.






**Q4:** Please explain your answer here (176 responses were received, the following selection gives a representative summary of the comments. The full list of comments can be found in **Appendix 2**).

- There's far too much concrete around and we need more green space and trees and plants planted.






**Q7: Please explain your answer here** (168 responses were received, the following selection gives a representative summary of the comments. The full list of comments can be found in Appendix 2).

- Already many, many cafes in the immediate area Not enough open green spaces in Swansea Centre.
- As long as they are individual local businesses, not chains like Costa or Gregg's etc. The current space is dominated by hard surfaces, more greenspace will soften the environment.
- Commercial food units will mean litter and also will be prohibitive for those who can't afford the food. Picnic area for people to bring their own food is needed.
- Cafes yes, restaurants no we have enough of them elsewhere in the city.
- I really like this idea. Most European cities in The Netherlands, Belgium and Germany have squares like these (e.g. Grote Markt, Antwerp). Provides a purpose for the area, which is good.
- If done sympathetically and with respect for each other's space, it could feel like a desired cosmopolitan space.
- It will bring footfall to the area and a sense of security.
- There's far too much concrete around and we need more green space and trees and plants planted.
- Not everyone will invest the time to carry takeaway food to the square from elsewhere. On-site facilities would certainly interest me.
- Keep and restore traditional features while adding green space. Do not build modern structures.

- A development of this nature needs a 'wow' element, something that draws people in.
- All depends on the design of it Commercial food units will mean litter and also will be prohibitive for those who can't afford the food. Picnic area for people to bring their own food is needed.
- Attracts tourists for photo opportunity and attractive to make passers-by way to stop I really like this idea.
- Do not see the point of allowing little children to get wet with nowhere for them to dry...under used feature this will be.
- Good if the rest is planned properly.
- It will depend on how it is maintained to avoid vandalism. Fountains that aren't always visible could work.
- Needed to allow flexible multi use. Old arrangements are poor and tired.
- The current fountain is way passed its sell by date and does not look good when in use.
- The ones I've seen in European cities are really nice.



- 3.6. The full set of responses are contained in **Appendix 2.**
- 3.7. The feedback from the survey indicates strong support for adding more greenspace to Castle Square with 94% of respondents agreeing with the proposal to do so. Comments in support of adding greenspace indicated that the existing hard surfaces are not welcoming. Some concerns were raised over future maintenance and over how existing problems of anti-social behaviour might be tackled.
- 3.8. In response to Q5 on the types of new greenspace that people would like to see there were generally high levels of support for all of the suggestions, with the exception of adding green space to allow for watching an event and for formal planting. The highest levels of support were expressed for more trees and shrubs, wildflower planting and more lawned areas.
- 3.9. Q6 gauged views on the proposal for new small cafes or restaurant units set within an attractive new family friendly space with canopies to provide shade and shelter for people to sit outside and relax. 70% of respondents agreed with the proposal. Positive respondents felt that this would bring footfall and a sense of security and provide a cosmopolitan space. Some concerns were expressed that there are already too many cafes and not enough green spaces and others raised concerns about potential for increased litter.
- 3.10. Over 70% of respondents agreed with the proposal for a new water feature. Positive responses thought that it would provide an attractive feature that would draw people in. Some caution was voiced about potential for vandalism.



## Design Commission for Wales, CADW, Pre-application and PAC

### **Design Review Panel**

- 4.1. Early engagement with the Design Commission for Wales (DCfW) has been carried out. The design team presented to the DCfW on 12 August 2021, key feedback key feedback can be summarised as follows:
  - The scheme would benefit from further exploration of the relationship between the site & its broader context, beyond the boundary line.
  - Exploration of alternative design concepts should be tested to ensure it is a space that can be properly used rather than simply entered and exited.
  - Explore the relationship with the Castle and other culturally significant associations of the site in more depth.
  - Accessibility & inclusivity: the design team were encourage to further consider how the square will be used by different user groups – particularly children and older people - to ensure all feel welcomed and safe throughout the day and night and all through the week.
  - Review in more detail the proposed removal or relocation of the "Leaf Boat sculpture by Amber Hiscott.
  - Careful curation of businesses, including a focus on small scale local business is important.

### CADW

4.2. Cadw have been consulted during RIBA Stage 3 design, and were involved in discussions during early Stage 1 development, as it relates to the setting of Swansea Castle, a Scheduled Ancient Monument and the Wind Street Conservation Area.

### **Pre-application**

- 4.3. A thorough pre-application process has taken place with Swansea Council planning team as well as other internal consultees such as highways officers, tourism and leisure officers, design, heritage and conservation officers.
- 4.4. Formal feedback from the Case Officer was received in April 2022. The response confirmed that the development is acceptable in principle. This described the positive planning policy context as well as containing some consultation responses and information to support the planning application. A copy of the pre-application response can be found in Appendix 1 of the Planning Statement.

### **Pre-application consultation (PAC)**



- 4.5. PAC is a statutory obligation in Wales where application documents are made available to the public and consultees to comment on for 28 days prior to the formal submission of the planning application.
- 4.6. PAC will run from 26th April until 24rd May. Any comments received during this time will be reviewed and amendments made to the proposals where appropriate before the planning application is submitted.

- 4.8. The planning application will be supported by a PAC Report which will fully explain the process and outcomes as well as summarise the comments received.



## 5. Conclusion and Next Steps

- 5.1. Feedback from stakeholders and a wider public audience has been sought on preliminary proposals for a new regeneration scheme for Castle Square, Swansea. The aim of the consultation has been to gain an understanding of how the space is being used at present and what, if any, problems can be identified with the existing space. The consultation has gauged public opinion on the proposed changes and sought feedback on where the scheme might be improved or tailored to better meet public expectations. The views of stakeholders and likely consultees to the planning application have also been sought to identify any key issues that need to be address in taking the design forward to a detailed planning application stage.
- 5.2. Whilst there has been a wide variety of responses to the public consultation what is clear is that there is a need to regenerate and rejuvenate the area and there is general support for proposals to do this, including strong support for additional greenspace and planting, and support for new food and drink outlets and a water feature. Some concerns have been expressed about how litter and anti-social behaviour can be addressed, but also recognition that the current square has similar existing problems.
- 5.3. Engagement with stakeholders identified areas that require further consideration in the design process, including:
  - There is a need to ensure the planting beds and new trees are maintained for biodiversity increase and a need to secure long term upkeep and maintenance. Links to the Tawe and Waterfront wildlife corridors were suggested.
  - Further engagement was encouraged on tree species with the Woodland Trust.
  - There is a need to consider SUDS structures, how they address DCWW easements and how they
    might link in with wider regeneration initiatives. The importance of incorporating SABS into the
    landscape design at an early stage was stressed.
  - The need to look at the practicalities of raised planters and whether more rain gardens might be incorporated into the scheme.
  - Careful choice of species in relation to the green roofs was discussed, along with their function.
  - Further engagement with the security consultees was encouraged on detailed design to address
    potential issues of anti-social behaviour, terrorism, crime and crowd safety.
  - Need to consider tactile paving, coloured paving and other disability issues.



- 5.4. The feedback that has been received so far has been used and will further be used to shape the proposals going forward and there will be further opportunities for engagement with the general public and local stakeholders through the planning application process.
- 5.5. The above is intended as a description and update on how the consultation process has been carried out thus far, and hopefully gives an indication as to the main issues raised by members of the community. As we hope the preceding section demonstrates, feedback from residents and local stakeholders is of great value to us and, as such, contact channels for the community engagement team will remain open. We encourage interested parties to get in touch with any further comments they have.
- 5.6. Effective engagement and consultation is an ongoing process that does not end with the submission of a planning application. Swansea Council, as the applicant are committed to continuing dialogue with local stakeholders.
